### **CARM R2 IMPLEMENTATION RELEASE UPDATE** **Customs Notice 24-17**

#### **CARM: Launch to External Clients Rescheduled to October 2024**

On **April 19, 2024**, the CBSA issued a news release to provide an update on its plans for the launch of the CBSA Assessment and Revenue Management (CARM) system.

The CBSA communicated that **CARM** will launch Release 2 internally at the CBSA on May 13, as planned, to advance the Agency's compliance and enforcement efforts.

Responding to uncertainty in the labour environment, the CBSA also indicated that it is preserving the status quo for industry when they account for duties and taxes. It is therefore the intention of the **CBSA to reschedule the launch to Trade Chain Partners (TCPs) to October 2024.**

Trillium would like to Thank all our clients who signed up for **CARM's** initial go live April 26th, you won't need to stress when October arrives. You as the client will be well positioned to navigate the **CARM** portal when October arrives.

**The extension to October does not take away the importance to register.** It is of extreme importance that each and every one of Trillium's clients, new and old, take this initiative seriously. CBSA is committed to the CARM portal and the October date is **FIRM**. So please take the time to register now.
